 - 1. Facilities
 - a. South stairwell drain has clogged several times since March 2023. A drain specialist jetted the pipes and it is functioning normally now.
 - b. Snow guards were installed on the slate roof. This cost will be put on the Board Agenda in August 2023 as a capital project expense.
 - c. Masonry work has not yet been completed.
 - d. Arms were added to two public computer chairs for improved accessibility.
 - 2. Next Chapter Project
 - a. The HVAC in the Community Room was repaired; Mrs. Hale has requested explanation of invoice and will request quote for a full maintenance contract in 2024.
 - b. LWC, Inc. put chair rail and door jamb protection out to bid.
- D. Staff The Youth Services Coordinator position has been posted. Trustees expressed their well wishes to Mrs. Taylor in her new employment.
- E. Collections, Services, & Programs
 - 1. WMPL subscribed to Mango Languages to replace the language learning database previously provided by the State Library of Ohio.
 - 2. WMPL will host a Braver Angels "Red/Blue" workshop on October 7, 2023. The workshop is designed to foster civil discourse among Republicans and Democrats.

 - 1. Trustees will pass a Resolution in August honoring the volunteers and community groups that have supported the Wright Memorial Public Library Native Plant and Pollinator Gardens.
