

2019 FINANCIAL REPORT ADDITIONAL 1.5 MILL OPERATING LEVY REQUESTED TO OFFSET REDUCED FUNDING AND RISING COSTS


Wright Library continued its long legacy of conservative fiscal management in 2019 by adding unspent funds to the Library's reserves. These reserves are a vital part of the Library's future as they are earmarked for necessary building repairs.

Beginning in 2020, revenues are expected to fall short of operating expenses due to a decade of reduced state funding and the rising costs of materials, wages, healthcare, technology, and facility maintenance. Without additional revenue, operating expenses and building repairs are expected to deplete the Library's reserves by 2024.

On March 17, Oakwood voters will decide on Issue 14, a 1.5 mill levy for Wright Library. The levy will protect Library services that Oakwood values and maintain the Library's historic building with infrastructure repairs and needed updates to make the Library more accessible, efficient, and comfortable.
