 - ii. The roof was inspected and there were no concerns; gutters will be cleaned out after all leaves have fallen.
 - iii. Sewage ejectors were repaired; covers for the sewage ejector and sump pump pits are in need of replacement.
 - iv. Some decorative low voltage lights are not working and need repaired.
 - v. A maple tree and a red bud tree will be planted this fall.
 - vi. A volunteer built a new base for WMPL's original card catalog; a refinisher is still being sought for remaining restoration work.

 - i. Staff Training Day was held on October 13, 2025. Staff evaluations indicated that the training sessions were valuable and appreciated by all staff.
